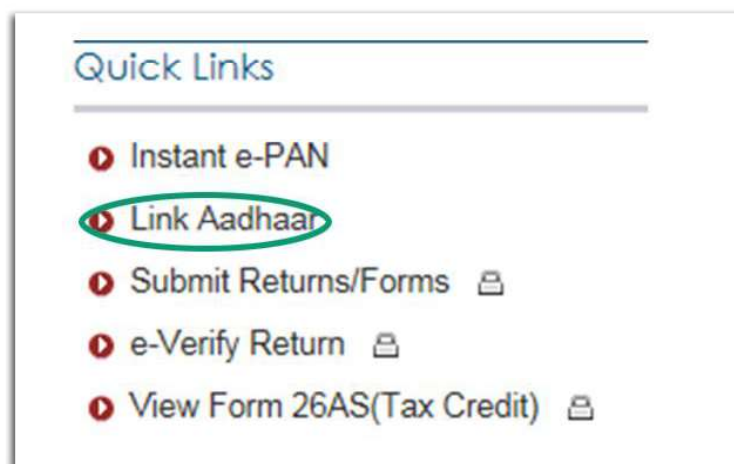


Linking of Aadhaar number with PAN can be done by following three options -

- 1 Through e-filing portal - without logging in to your account (3 step procedure)
- 2 Through e-filing portal - by logging in to your account (5 step procedure)
- 3 Through mobile phone - SMS

Option 1: Link your PAN and Aadhaar without logging into e-Filing portal

- 1 Go to 'www.incometaxindiaefiling.gov.in'
- 2 Under the "Quick Links" section, click on "Link Aadhaar".



- 3 Enter the following details in "Link Aadhaar" screen:
 - PAN
 - Aadhaar Number
 - Name as exactly specified on the Aadhaar card
 - If only Year of birth is mentioned in Aadhaar card, select checkbox

After entering the details click on “Link Aadhaar” button. Post verification from UIDAI, the linking will be confirmed.

- 2 Log in to the e-Filing portal of the Income Tax Department by entering the login ID, password if already registered

- 3 After logging in to the site, go to 'Profile Settings' and click on 'Link Aadhaar'.

- 4 Details such as name, date of birth and gender will already be mentioned as per the details submitted at the time of registration on the e-Filing portal. Verify the details on screen with the ones mentioned on your Aadhaar card. If the details match, enter your Aadhaar number, and Name as per Aadhaar and click on the "Link Aadhaar" button.

- Once Aadhaar-PAN linking is completed, you can e-Verify your return using Aadhaar, if your mobile is registered with Aadhaar.

Instructions

- Enter your Aadhaar Number in the text box provided below and Click on "Link Aadhaar" button.
- Income Tax Department will validate your Name, Date of Birth, Gender as per PAN and Aadhaar Number with UIDAI. Please note that if the details do not match, the Aadhaar Number will NOT be linked to your PAN.

- 5 A pop-up message will inform you that your Aadhaar number has been successfully linked to your PAN card.



Option 3: Linking of Aadhaar Number and PAN via SMS (mobile phone)

Now you can link your Aadhaar and PAN through SMS also. It can be done by sending an SMS to either 567678 or 56161. Send SMS to 567678 or 56161 from your registered mobile number in the following format:

UIDPAN<SPACE><12 digit Aadhaar><Space><10 digit PAN>

Example: UIDPAN 123456789123 AKPLM2124M
